**A BY-LAW TO APPOINT THE COUNTY COMMITTEES FOR THE
ENSUING YEAR OR UNTIL THEIR SUCCESSORS ARE APPOINTED**

WHEREAS Section 102 of The Municipal Act, R.S.O. 1990 as amended, provides that every Council may pass by-laws for governing the proceedings of Council;
