### **BY-LAW NUMBER 10-00**

## A BY-LAW RESTRICTING THE WEIGHT OF VEHICLES PASSING OVER BRIDGES IN THE COUNTY OF RENFREW

**WHEREAS** Subsection 2 of Section 123 of The Highway Traffic Act, R.S.O. 1990, as amended, provides that the municipal corporation or other authority having jurisdiction over a bridge may by by-law, limit the gross vehicle weight of any vehicle or any class thereof passing over such bridges, and the requirements of subsection 1 with respect to the posting of notice apply thereto;

**AND WHEREAS** it is deemed expedient to limit the weight of vehicles passing over a bridge in the Corporation of the County of Renfrew;

**THEREFORE** the Council of the Corporation of the County of Renfrew hereby enacts:

- 1. No vehicle or combination of vehicles or any class thereof, whether empty or loaded, shall be operated over the bridges listed on Schedule 'A' with weights in excess of the limits listed in Schedule 'A'.
- 2. Any person violating the provisions of this by-law shall be subject to the penalties provided in Section 125 of The Highway Traffic Act, R.S.O. 1990, as amended.
- 3. This by-law shall not become effective until notice of the limit of weight permitted in compliance with the regulations under the Highway Traffic Act has been posted in a conspicuous place at each end of the bridge.

**READ** a first time this 24th day of February, 2000.

**READ** a second time this 24th day of February, 2000.

**READ** a third time and finally passed this 24th day of February, 2000.
