**BY-LAW NUMBER 80-07**

**A BY-LAW TO EXECUTE AN AGREEMENT WITH  
ENVIRONMENT CANADA FOR THE OPERATION  
OF A WATER MONITORING STATION ON COUNTY ROAD 19**

WHEREAS Environment Canada has constructed and wishes to operate and maintain a water monitoring station on County Road 19 (Mud Lake Road) adjacent to the Muskrat River at Johnston Bridge in Lot 28, Concession 1, geographic Township of Stafford;

AND WHEREAS it is deemed necessary and desirable that the Council of the Corporation of the County of Renfrew enact a by-law authorizing the Corporation to enter into an agreement with Her Majesty the Queen in Right of Canada as represented by the Minister of the Environment, pertaining to the construction, operation, maintenance and decommissioning of the water monitoring station.

NOW THEREFORE, the Council of the Municipal Corporation of the County of Renfrew hereby enacts as follows:

1. That the Warden and Clerk are hereby authorized to sign and seal all things, papers and documents necessary for, or incidental to the execution of the agreement.
2. The agreement attached hereto and annotated as Schedule "A" is hereby deemed to be a schedule to this by-law.
3. That this by-law shall come into force and take effect upon the passing thereof.

**READ** a second time this 29<sup>th</sup> day of August, 2007.

**READ** a third time and finally passed this 29<sup>th</sup> day of August, 2007.

7. If the Licensee defaults in performing any of its obligations under this Agreement, the County shall give written notice to the Licensee of such default giving the Licensee ninety (90) days to remedy the default, failing which the County may terminate the license granted under this Agreement. Any waiver by the County of any breach by the Licensee of any provisions of this Agreement shall be without prejudice to the exercise by the County of all or any of its rights or remedies in respect of any continuance or repetition of such breach.
8. The County or the Licensee may terminate this Agreement on twelve (12) months written notice for any reason.
9. Any notice required to be given to the County or the Licensee under this Agreement shall be sufficiently given if delivered or mailed postage prepaid to the addresses below. Such notice shall be deemed to have been received on the date of its delivery or in the case of mailing, three (3) business days after it was delivered to the post office.
10. Upon termination of this agreement, the Licensee shall remove all buildings, equipment and associated works and shall restore all lands to the satisfaction of the County.

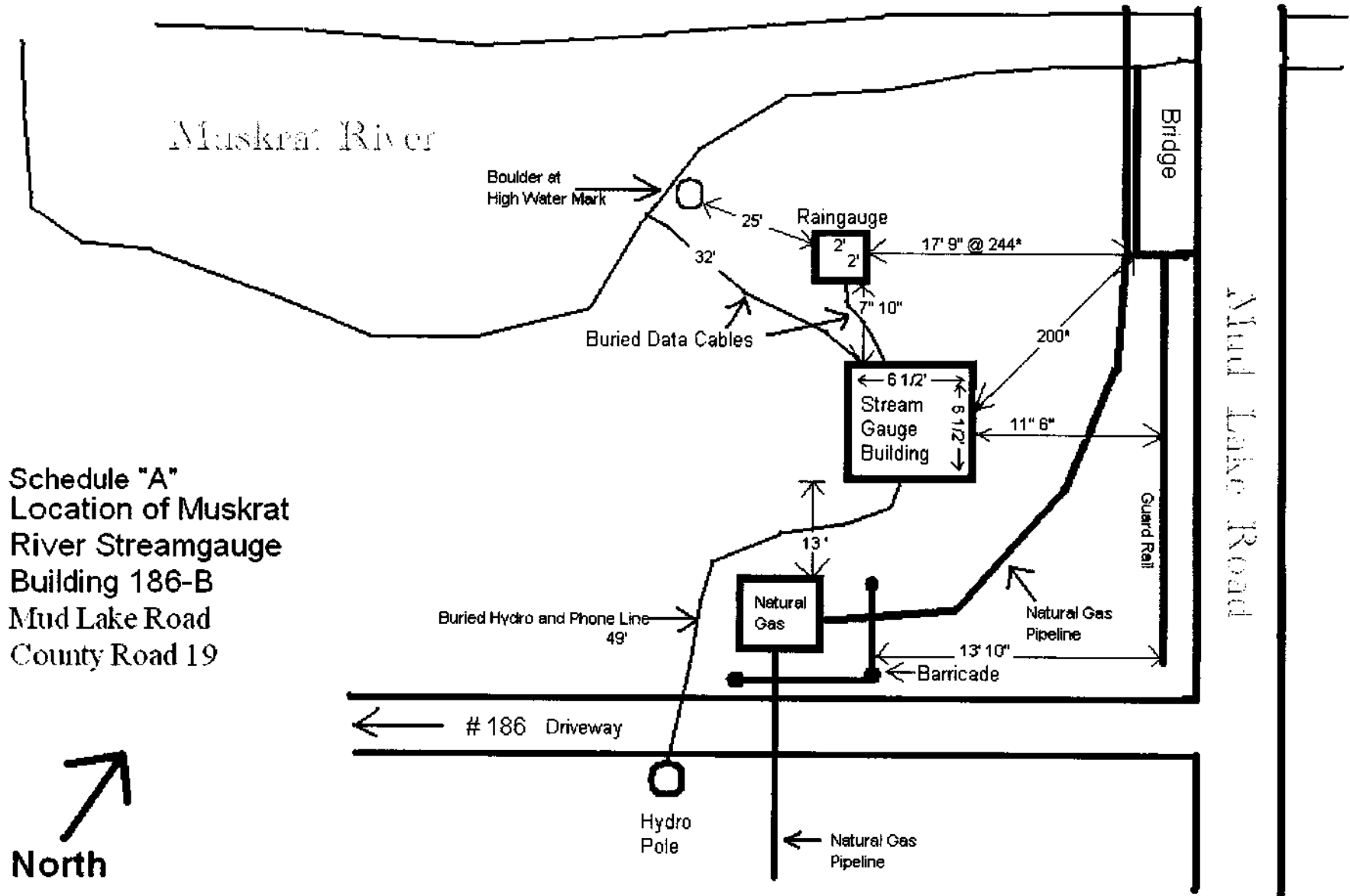
