## BY-LAW NUMBER 1-10

### A BY-LAW TO APPOINT THE COUNTY COMMITTEES FOR THE ENSUING YEAR OR UNTIL THEIR SUCCESSORS ARE APPOINTED

WHEREAS the Municipal Act, 2001 provides that every Council may pass by-laws for governing the proceedings of Council;
